10. It is understood that should this bid be accepted, it will become a part of the Contract documents upon the signing of the Contract. Failure to comply with any part of this bid will be taken as a failure to comply with said Contract and will be just cause for rejection of the work.
11. Bidder hereby certifies that:
 - a) This bid is genuine and is not made in the interest of or on behalf of any undisclosed person, firm or corporation and is not submitted in the conformity with any agreement of rules of any group, associations, organization or corporation.
 - b) Bidder has not directly or indirectly induced or solicited any other bidder to put in a false or sham bid.
 - c) Bidder has not solicited or induced any person, firm, or corporation to refrain from bidding, and;
 - d) Bidder has not sought by collusion or otherwise obtained for himself any advantage over any other bidder or over the District.
